Deadly Addiction

Horrifying truths about Drug and Alcohol Abuse. Has it really come to this?

Drug abuse has haunted our community, and is continuing deteriorate by starting out as a mild problem, then turning into more severe problems. Victims are spread throughout our community, such as the fatal drug story on Brian Bishop. Sites have shown that most drastic situations have happened in 2017. More than 70,000 have died from this abuse in just 2017, with results from 2018 still calculating. Many say this abuse is caused from depression, but interviews with Jennifer Huynh, Erin Williams, and Mark Polak include what they really think is going on.

On January 17, 2019 Erin Williams, the health teacher at the Dr. An Wang Middle School, was asked the familiar question on her thought about drug and alcohol abuse. Williams replied, "I think that

into that trap of abusing a substance... it's important to have good programs and places to educate people about those dangers...." Mark Polak, a retired Lowell police officer, had a similar response to the same question when he was asked on January 23, 2019. "I think we need to get people that are involved in it, the help they need and there's several programs and ways of doing that out there. We just need to make people aware of the help that's out there for them." The facts of the addiction trap by Gulf Breeze include the same type of information Williams and Polak talked about. The abusers are unaware of their addiction, and it becomes a routine. The abusers fall into a trap and only focus on drugs. Like Polak had stated, Gulf Breeze also wants to make the abusers aware of the help they need, and Gulf Breeze is a program that is working to cure these addiction prob-

On January 23, 2019 Mark Polak, a retired police officer in the city of Lowell, replied to the questioning of the effect of drug abusers on our lives. Polak replied, " If you run into someone who's driving a car, that's under the influence of some kind of substance they could hurt you or your family, and crash into you or hurt someone else." Drinking and driving is illegal and can lead to serious punishments. A 61 year old man driving under the influence, rear ended a couple, killing the woman in the passenger seat, Margo Sabater resulting with her husband, in serious condition, at the hospital. The crash, in Sumner Washington, hurt several other citizens too. The deadly crash destroyed the car of the Sabater couple. The ford truck with the drunk

driver, rear ended the Sabater car and sent it barreling into a blue toyota, also injuring those passengers. To add on to the topic of drunk driving, a 5 year old died from a two-car wreck, that a driver coming from a bar caused. Isreal Suarez Lugo, the 34 year old driver that killed Giselle Luviano, has been pressed with charges. The wreck happened on January 20, 2019, in the Greater East End, and injured several other citizens. The truck driven by Lugo, had been swerving out of control and sped through a red light when it crashed into the black Cadillac, injuring all four of the people inside. The 15 year old and the two other adults inside had minor injuries, but Luviano had been rushed into surgery for traumatic brain injuries. Lugo could spend 20 years in prison, but the results are not final yet.

On January 25, 2019, Jennifer Huynh, the nurse at the Dr. An Wang Middle School had been asked multiple questions on her thoughts. Huynh had been asked her thoughts on drug and alcohol abuse, Huynh replied, "I think that there are people who need assistance and that there are a lot of social stigmas associated with abuse." Many sites agree with Huynh. Drug abuse can affect your selfesteem, damage relationships with loved ones, and keep the addicted from getting treatment to help their addiction. Huynh later continued on her thoughts on the effects of drugs in her life. "It's kind of my job to try and take care of them. I was a psychiatric nurse for a little while and I had a lot of fun with that, but it comes down to being a disease similar to other chronic conditions. They just need help and medical assistance." Drug addiction is considered a disease because of the complex attachment. The abusers need help to be able to overcome this attaching addiction. It is almost physically impossible to overcome this addiction alone, so abusers have the option to go to researchers to overcome their addiction the proper and effective way. Huynh also added the explanation of the dangerous drug fentanyl. She stated,"It's a very concentrated form of a painkiller, it's a narcotic, and it's being cut with the cheaper street version called heroin, and unfortunately it has caused a severe amount of overdoses, because it's just so potent." There has been a crisis on the U.S. border, where very large amount of fentanyl was attempted to be smuggled in from Mexico. Nearly 254 pounds of fentanyl was found heading into Arizona. This drug is 80 to 100 times more powerful than the drug morphine, and the amount that was found had enough power to kill more than 56 million people. The Mexican driver had been arrested, and tests shows just 2 milligrams of fentanyl, can be lethal.

In January 2017, over 70,000 people died from overdose and the results from 2018 are still calculating. Overdoses are still increasing and the US population is decreasing. Drug addiction is a relapse. Stop and think, maybe someone you love has been hiding their stress and depression. Maybe that loved one, whether they're a family member, friend, or partner, they could be a victim next. Their presence could be ripped away from you, because of drugs. Don't let this happen. Fight like your life depends on it, because it does.

Culpable School Debate



Police Brutality Is Still On The Rise, And Doesn't Look Like It's Going To Stop Anytime Soon.

People are still scared about what's gonna happen next when they're pulled over.

In America, it seems like police brutality is a common act happening weekly. "In 2017, 1,147 people were killed in America, and 25% of those killed were African-American, despite being only 13% of the population, and were in the hands of a police officer who used excessive force. In 2018, 1,166 people were killed in police custody.

When interviewed, Jennie Welch, a Community Service Officer for the Tewksbury Police Department since 2003, said that, "The danger in police work varies from call to call...every call has to be handled with professionalism, and tactically sounds to protect the officer."

Those three words, "protect the officer" can be very biassed and controversial. There are many other non-lethal ways that an officer can protect themselves. Pepper spray contains capsaicin, the ingredient in chili peppers that makes your eyes water and your nose run like a faucet.

Most officers agree, that when some cases of police brutality are reported, the sides of the story can be different.

Sonia Chanthaboun who was a Reserve Officer for the Tewksbury Police Department, agrees with the other officers. She says that, "Everything is recorded, and posted online for people to see, and the truth is not always what people may see."

Chanthaboun also said that officers should have body cameras and they shouldn't be afraid to wear them, if they're not doing anything wrong.

In fact, since 2005, there have only been 13 officers convicted of murder or manslaughter in fatal on-duty shootings, according to data provided to The Huffington Post by Philip Stinson, an associate professor of criminology at Ohio's Bowling Green State University. Stinson's data doesn't include cases in which civilians

died in police custody or were killed by other means, or those in which officers only faced lesser charges.

Alice Mwangi a student of the Dr. An Wang Middle School agrees with what Chanthaboun has to say, by saying, "Police Brutality can be looked at in two ways. It depends on the case."

Rahimah Rahim, who is the mother of Usaamah Rahim, who was killed by an FBI agent and a Boston police detective in Roslindale on June 2nd, 2015, demands that her son's case be reopened. Usaamah Rahim was a suspected ISIS-affiliated extremist. Rahim was confronted by the FBI agent, and the detective, a month after he bought three knives off of amazon. He was posed as an "Imminent Threat" and was ultimately gunned down.

Police brutality can happen anywhere and at anytime. It can also happen to anyone. No matter what your race it, it may happen.

Police brutality is so common these days, that it's easy for journalists/reporters to find different cases of it. When interviewed, Kim Riccardi of the Tewksbury Police Department who has been an officer since 2002, said that "When there are a few people that do the wrong thing..it paints everyone with the wrong brush and we all get judged based on what a few individuals do."

When there are reports of police brutali-

ty, all of the news stations are quick to jump onto the story, and try to get as much detail and information about what the full story is. Some news stations can be biased about stories. They will focus on one side of the story, even though there is clear evidence supporting the other side.

The amount of time young people spend on social media is also problematic. This is especially true because of all of the other things in their lives that could stand to be neglected because of excessive usage of social media. Oxford, Swansea and Birmingham reviewed previous studies on cyberbullying which involved more than 150,000 under-25s across 30 countries over a 21-year period.

They found that cyberbullying raised the risk of self-harm or suicidal behaviour 2.3 times. "I don't think social media itself is causing kids to harm themselves, I think it's the people behind the screen sending the message..." says Mr. Stahl, principle of the Dr. An Wang middle school.

Social media shouldn't be used to hurt others or throw hate at each other. Social media should be used to share joyful pictures and funny video with friends and family, to socialize with others, and make new friends. Social media shouldn't be a place where you go to get bullied. What will social media even be in the next few years? Will it get worse?



Teenager In Florida Are Able To Buy A Military Style Gun Before Beer.

On February 14, 2018 Nikolas Cruz was accused of opening fire on a high school in Florida named Stoneman Douglas High School killing 17 people, age of 19 using an AR 15 military style gun. Officials claim he was a "troubled child".

In Florida, legally you must be 18 to buy a rifle or shotgun from a licensed dealer, but have to be 21 with a licence to buy a handgun from a licensed dealer. An 18 year old can walk into a auction selling guns making it easier for teens to buy a gun and come out with a shotgun or rifle, the reason the law is made like this is because the time the state officials were enforcing gun laws a AR 15 or military style weapons were not as famous as they are now.

Nikolas Cruz wasn't the only person to have his hands on a military weapon so easily, last year in october a 64 year old man killed 57 people at a Las Vegas music festival with just an assault rifle. The AR 15 is most commonly seen in shootings because of how easy they are to get hands on, Caleb Walsh a student of Dr. An Wang Middle School says "a lot of teens may think it's a joke at first but if there's a teen that thinks he really wants to do this they could actually shoot up the school and probably actually kill people".

In Texas, Walmart has a store policy that allows you to carry a visible handgun into the store, and the employees are responsible for finding out the customer is legal age and has a license for that gun.

On the other hand, guns are used in self defense and hunting, this is originally why gun were allowed to be bought at a early age, but an AR 15 is a military style weapon and it depends on how you press the trigger, how many shots come out. 3. God of War:


